Delayed Gifting Program

(some examples)

please check desired option

- Testamentary Bequest**
In your will, you leave assets to GRHS Endowment Fund, which transfer at your death.
- Charitable Remainder Annuity Trust (CRAT)**
You place cash and/or real estate in trust. The trust pays you a fixed income each year. At death, the assets of the trust transfer to GRHS Endowment Fund.
- Charitable Remainder Unitrust (CRUT)**
REAL ESTATE: You donate real estate to trust. It, in turn, pays you income for life. You may receive a tax deduction for the value of the real estate's remainder interest and you may avoid capital gains tax. At your death, the real estate transfers to the GRHS Endowment Fund.
AND/OR
CASH: You place cash in trust. Trust pays you fixed percentage payments based on not less than 5% of the fair market value of the assets. At your death, the assets transfer to the GRHS Endowment Fund.
- Life Estate**
You deed real estate to the GRHS Endowment Fund while retaining the use of it for the rest of your life. At your death, the real estate transfers to the GRHS Endowment Fund.
